We will need 4 new sets for Novice House, and 2 sets for Novice Select With also have 2 new goalies playing travel who used equipment from house league teams last year, and are using those sets for this upcoming season.  Starting to see names signing up for Novice- a few banking on Novice select so no convenors right now.
- Select coaches will be tough to name right now. Not sure who coaches are yet in most divisions. U8
 volunteer has come forward and comes highly recommended but U8 won't kick off until house
 league starts. May need to look at WFCU for ice for select teams. Accounts for select teams are being
 set up.
- Need volunteers for sign in desk for opening weekend.
- Have reached out to the Windsor Spitfires new Coodinator (Matt Sfetkidis) of fan development, trying to set up meeting to discuss Mickey Renaud game and possibility of having Spitfires show up at a few practices like last year. Will try to reach out to more people. Greg volunteered to help as well.
- Coach application forms are live on the site. Looking to run report from the website- Jordan can help Trevor do this.
- Some game times might need to be juggled to accommodate half boards. We will find out the level of assistance for half board removal by town staff.

Travel Report

- Novice Select will fall under the Travel Program and replaces Novice Major
- Novice Select will use Novice Major Jerseys
- Novice Select Coach has been selected Congrats to David Halliwell
- Novice Select Tryouts will be September 6th Sept 8th
- Novice Select will play 4 games in October and 14 games between Nov and Jan 15th.
- Must carry 16 skaters and 2 goalies. Will play 4 on 4 with mini games of 24 minutes with 1-2 minute shifts using a buzzer. Regular nets will be used. Two face-offs per game.
- After Jan 5th Bluewater will decide at later meetings which direction they will head, which is when this age group moves to full ice based on the Hockey Canada Guide lines.
- Scheduling meeting was completed and Most teams in the end scheduled everything in accordance to the rules laid out.



- Concussion clinics for Bantam and Midget players, going to try a new scheduling format this year of 6 players per time slot. Each time slot takes 30 minutes. Horwood room is booked-Jordan to look into using Board room.
- Rowan's Law concussion awareness is an acknowledgement form that must be signed off by every player and for the travel players we are going to pass out enough forms for every team for the first practice and expect them to be handed back in before their first game.
- OMHA portal Money for Travel Permits Last year the association loaded \$750 to the portal for travel permits. We currently have \$270 left in the system so we will need to top off that especially that we have more teams this year.
- Travel Permit Requests will be mandatory to use the online form via TSMHA website this year. I have updated the form to insure the request fulfills everything needed to successfully request a travel permit.

- E game sheets will be mandatory next year- will look into bingo funds to purchase ipads.
